



### AG AND BUSINESS COMMUNITIES CALL ON STATE LEADERS TO ADDRESS HEALTH CRISIS

A coalition made up of business and agricultural organizations that is calling on Governor Gavin Newsom, Secretary Mark Ghaly, and Attorney General Rob Bonta to address the ongoing public health crisis in the Central Valley as result of the Madera Community Hospital closure. The hospital has been opened since 1971 and served as the primary medical facility for the county's 130,000 residents, providing services for maternity health, emergency room and ambulatory needs.

President Ian LeMay stated, "Far too often the Central Valley and our communities have been overlooked and underserved when it comes to our health care needs. This closure has had rippling effects on hospital facilities throughout the Valley causing serious worry about availability to access critical and emergency services. State leaders have a responsibility to address these issues and supply the area with the resources necessary to ease the burden caused by the closure of the Madera Community Hospital."

CFFA will continue to work with businesses and elected officials on the local, state and federal levels to find a viable solution to ensure that residents in our communities can receive the health care services that they need. To read the coalition letter please, see attached.
