### U.S. SUPREME COURT DECLARES ACCESS TO FARMS BY UNION ORGANIZERS UNCONSTITUTIONAL



The California Fresh Fruit Association is pleased with the U.S. Supreme Court's decision in *Cedar Point Nursery v. Hassid.*On June 23<sup>rd</sup>, the Court held that under California's Agricultural Labor Relations Act (ALRA), access by union organizers to come onto the private property of farmers and landowners to promote the union violates the Fifth Amendment of the U.S. Constitution.

According to Chief Justice John Roberts, who authored the opinion, "unlike a mere trespass, the regulation grants a formal entitlement to physically invade the growers' land. Unlike a law enforcement search, no traditional background principle of property law requires the growers to admit union organizers onto their premises. And unlike standard health and safety inspections, the access regulation is not germane to any benefit provided to agricultural employers or any risk posed to the public."

CFFA President Ian LeMay said, "This ruling involving Cedar Point Nursery and CFFA member Fowler Packing Company protects the constitutional rights of agricultural employers and brings the ALRA access rule into alignment with the National Labor Relations Act. For 45 years, California's farmers have seen their property rights ignored by the Agricultural Labor Relations Board by allowing organizers onto their property. No other industry in the United States, including California, has had to allow union organizers onto their property in a similar manner. We appreciate both Fowler Packing and Cedar Point's efforts in leading the fight to restore the same property rights that are enjoyed by all other industries in the United States, to California farmers."

### EMPLOYER MASK VERIFICATION AND ATTESTATION FORM

On June 17<sup>th</sup>, Cal/OSHA Consultation readopted its changes to the COVID-19 Emergency Temporary Standard (ETS). Governor Gavin Newsom signed an executive order that made the amendments effective immediately.

The ETS changes state that employees who are fully vaccinated against COVID-19 are no longer required to wear face coverings in the workplace, except for in certain situations. Employees who are not vaccinated must continue to wear a mask while at work.

In order for businesses to comply with these rules, employees who do not wish to wear a mask at work must either provide proof that they are fully vaccinated or sign an attestation form.

\*Please note, employees are not required to inform their employers of their vaccination status.

CFFA has provided a sample letter attached that an employer can use as a template.

### UPDATED EMERGENCY TEMPORARY STANDARDS FAQ'S

A common question asked is whether businesses could allow employees to self-attest as to their vaccination status. The FAQs confirm that self-attestation is sufficient, but employers will have to document each employee's status

Currently, the CRC is holding meetings throughout the state to gather input from community and interest groups and organizations, including businesses. The CRC presentation will give an overview of the redistricting process and information on how the process will affect the local, state, and federal political landscape.

#### CAL POLY FUEL CONSUMPTION/COST RESEARCH STUDY


