## SECRETARY OF INTERIOR HAALAND VISITS THE CENTRAL VALLEY



On August 17<sup>th</sup>, the California Fresh Fruit Association's (CFFA) past Chairman Kevin Herman of **The Specialty Crop Company** met with United States Interior Secretary Deb Haaland at his ranch to discuss the effects of California's ongoing drought and the need for additional water

infrastructure investments. Secretary Haaland's visit was hosted by Congressman Jim Costa, and they were joined by California Department of Food and Agriculture Secretary Karen Ross, Natural Resources Secretary Wade Crowfoot, and U.S. Bureau of Reclamation Commissioner Camille Touton.

Past CFFA Chairman Kevin Herman stated, "We are happy to welcome Secretary Haaland to our ranch. It is pretty simple; California is running out of water. Climate change, drought and millions of people moving here over the past several decades have all had an impact on our water supply. More storage is the quickest and easiest solution to address this problem. The agriculture industry is doing its part by utilizing a variety of tools like drip irrigation, deficit irrigation, and groundwater recharge. Along with CFFA, we look forward to working with Secretary Haaland and the Department of Interior to find solutions to protect California's water supply."

CFFA President Ian LeMay commented, "We appreciate the time Secretary Haaland has taken to visit California and, specifically, to meet with CFFA members to hear first-hand about the effects of the drought on agriculture. Every person in our state, nation and world relies on agriculture, and we value when our state and nation's leaders take the time to get boots on the ground to learn about the impacts of drought on our industry. Lastly, I thank Congressman Costa for facilitating this visit and for his continued advocacy and partnership. "

This week's visit by federal and state officials follows last year's passage of the Infrastructure Investment and Jobs Act, the recent enactment of the Inflation Reduction Act, and the announcement of Governor Newsom's "California's Water Supply Strategy - Adapting to a Hotter, Drier Future," which collectively promise renewed federal and state investments for managing California's water resources. #### ZERO EMMISSION AGRICULTURAL TRUCK PROGRAM

On August 1<sup>st</sup>, the San Joaquin Valley Air Pollution Control District launched the Zero-Emission Agricultural UTV Program.

The Zero-Emission Agricultural UTV Voucher Program provides incentives for the replacement of existing diesel or gasoline-powered UTVs and tractors with less than 25 horsepower with new, zero-emission ones to qualified individuals, businesses, educational institutions, and non-profit organizations involved in California agriculture. Funds are provided on a first come, first serve basis.

The incentive amount for the replacement of the existing unit to purchase a new zero-emission UTV is up to 75% of the eligible cost of new equipment, with a maximum eligible funding amount of \$13,500. For more information, please visit www.valleyair.org/grants or email grants@valleyair.org.
