INAUGURAL JAPAN STONE FRUIT AUDIT DEEMED A SUCCESS

In late July, Japan's Ministry of Agriculture Fisheries and Food (MAFF) conducted its first audit California Stone Fruit exporters after pausing all travel in 2020 due to COVID-19. As a condition of market access, MAFF must conduct annual audits of export programs nectarines and plums which include mandatory fumigation and strict handling protocols. While the final report has yet to be delivered to USDA, the auditor reported no findings over the course of the week. "The fact that our shippers were this successful

on the first audit is significant. This demonstrates industry's commitment to adhering to the program and maintaining market access," said Caroline Stringer, CFFA Director of Trade.

"Prior to gaining access for plums," Stringer continued, "MAFF conducted a pre-clearance program for nectarines which required a MAFF inspector be present for the entire season. Transitioning to an audit program for both commodities to be conducted concurrently confirms MAFF's recognition of the industry's achievements."

ZERO EMMISSION AGRICULTURAL TRUCK PROGRAM

On August 1st, the San Joaquin Valley Air Pollution Control District launched the Zero-Emission Agricultural UTV Program.

The Zero-Emission Agricultural UTV Voucher Program provides incentives for the replacement of existing diesel or gasoline-powered UTVs and tractors with less than 25 horsepower with new, zero-emission ones to qualified individuals, businesses, educational institutions, and non-profit organizations involved in California agriculture. Funds are provided on a first come, first serve basis.

The incentive amount for the replacement of the existing unit to purchase a new zero-emission UTV is up to 75% of the eligible cost of new equipment, with a maximum eligible funding amount of \$13,500. For more information, please visit www.valleyair.org/grants or email grants@valleyair.org.
